Dear St. Paul School Families,

January 25, 2017

This school year is going by fast. Soon it will be spring and summer. Planning is underway at St. Paul Parish and School for the coming academic year (September 2017 to June 2018). If you are planning on having your children attend St. Paul Parish School in September and desire some help with the cost of tuition then it is time to apply for the Parish Tuition Subsidy Program.

This program is set up to assist “qualifying Catholic” families with the cost of tuition per child. The criteria for a “qualifying Catholic” family is outlined and defined in depth in the St. Paul School Outline Handbook. Even if you are familiar with the criteria from the years past, I encourage you to take another look at them in the handbook.

Each of the three criteria is important and required of each family receiving assistance through the program. Briefly the three criteria are:

- Your family is registered in St. Paul Parish and you regularly attend Saturday evening or a Sunday morning Mass throughout the year.
- You contribute to and participate in parish and school activities.
- You support the parish financially in accordance with your ability to pay in a demonstrable manner (weekly offertory envelopes or electronic giving).

The criteria for the Parish Tuition Subsidy Program were established by the Archdiocese of Portland. St. Paul Parish and School will adhere to these criteria.

We have a special parish and school at St. Paul. The administration and staff are grateful for the families who worship with us and the student who grace us with their enthusiasm and spirit. We want to continue educating your children and assist you raising fine faith-filled young adults. Thank you for all you have done for the parish and school.

2017-18 Saint Paul Parish Tuition Subsidy Form

Parish tuition subsidy of \$1025.00 per each child is available to qualifying Catholic families. As part of our annual registration process, it is necessary to apply for Parish tuition subsidy by completing this form and submitting it for pastor approval and signature. Father David will return it to our school office. Under Archdiocesan policy, each child enrolled in a Catholic elementary school, whose family is registered and participating in its parish, qualifies for eligibility in the subsidy plan.

The qualifications for school subsidy have the following general parish participation considerations:

- Your family is registered in St. Paul Parish and you regularly attend Saturday evening or a Sunday morning Mass throughout the year.
- You contribute to and participate in parish and school activities.
- You support the parish financially in accordance with your ability to pay in a demonstrable manner (weekly offertory envelopes or electronic giving).
